Programme at your Institution under The West Bengal University of Teachers' Training, Education Planning and Administration for the academic year 2021-2022 subject to the fulfillment of the following terms and conditions:

1. The college shall be guided by the NCTE Regulations 2014 in respect of appointment of teaching and non-teaching staff, purchase of books, audio-visual material and automation of the library.
2. The college will continue to organize and equip the laboratories as per stipulation of NCTE. Other infrastructure are to be maintained as per NCTE.

5. Appointment of faculty already done/ to be done in future and their pay and allowances must follow the latest NCTE, UGC and State govt. norms. Payment of salary must be through proper procedure directed by the Govt.

In respect of maintenance of academic and financial discipline the college will strictly follow norms of NCTE (in strict observance of the latest notification)/State Government Orders issued from time to time and relevant conditions/rules of the Affiliating University in this regard especially with respect to the minimum number of teaching days in an academic session as stipulated by the Affiliating University/NCTE.
